- 2. A fourth grader, Lauren Mannlein, from Sparke School won the Child Abuse Prevention Services Poster Contest, "Steer Clear of Bullies."
- 3. Elizabeth Watson, a Kindergarten student from Sparke School, was chosen as a statewide winner in a fire safety poster contest sponsored by the Fireman's Association of the State of New York. Her poster will be featured in the 2008-2009 FASNY Calendar.
- 4. René DeLorenzo, a memorial middle school fifth grader, won Senator Hannon's "There Ought to Be a Law" Contest.

- 8. Island Trees School District has been designated as a high performance school district for the second year in a row.
- 9. The district undertook the refinancing of district bonds. Moody's upgraded Island Trees' rating from A2 to A1. The rating upgrade reflects the district's well-managed financial position supported by a history of positive operating results and healthy reserve levels. The A1 rating also incorporates the district's stable tax base and a manageable debt position. Proceeds from the sale will refund bonds originally issued in 1997. The refunding is expected to generate a net present value savings of approximately 6.39% of refunded principal, without extending the maturity of the debt. Mr. Parla thanked Mr. Carambia and the Board of Education for a job well done.
